

# In their own words

After receiving a scholarship to go to 'vet' school instead of 'med' school, Merab Acham decided to learn as much as she could about both human and animal health, going on to complete a degree in Veterinary Medicine and human epidemiology.

I wanted to go into human medicine, but when I received a scholarship for vet medicine instead, I decided that it was my only route to becoming a doctor, so I took it. I ended up enjoying the course because of the breadth of work. I studied a resistant parasite in pigs for my undergraduate project, which is really what sparked my original interest in AMR. Local farmers were complaining that their pigs were sick even after treating them with the normal chemical- effectively the parasite had become resistant to the chemicals and drugs.

After working as a vet for a few years, I decided I wanted to continue working on issues, like the pig parasite, that affect humans and animals so I studied epidemiology. I now work for the government in Uganda and I have more time to do research that helps shape our national policies. I am grateful for the fellowship opportunity, because this is exactly the sort of research I've always wanted to do.

Over the past several months of the programme, I've realised how much there is to learn about AMR. The Fellowship has expanded my technical knowledge but also helped remind me that sometimes I need to stop thinking like a scientist and consider the anthropological or social context of information. As researchers we need to understand 'why' something is happening, not just 'what' is occurring.

The Fellowship has also been invaluable in bringing both the human and animal sectors together to work on AMR. We are not accustomed to working together, but we can't work in silos if we want to create sustainable solutions. Ultimately, our collaboration is essential to achieve the outcome we want-sustainable policy change that restricts the use and consumption of antibiotics across human and animal sectors.





The Government of Laos and the UK Government signed a Memorandum of Agreement in October 2018 in support of the Fleming Fund in Laos. Present at the signing ceremony was HRH Princess Beatrice of York, HE Ambassador Hugh Evans, Lao Minister of Health Bounkong Syhavong, Mott MacDonald staff and others.

After the event, Dr Anthony Huszar, Mott MacDonald's Regional Coordinator for South East Asia, reflected on the importance of collaboration for the programme's success:
