Antimicrobial resistance surveillance in Europe 2022: 2020 data - Antimicrobial resistance remains a major public health concern in the WHO European Region, with estimates from the European Union/ European Economic Area (EU/EEA) alone showing that each year more than 670 000 infections are due to bacteria resistant to antibiotics and approximately 33 000 people die as a direct consequence.

This report is the first in a series published jointly by the European Centre for Disease Prevention and Control (ECDC) and the WHO Regional Office for Europe that includes AMR data from invasive isolates in Europe. Read the report HERE.



Global burden of bacterial antimicrobial resistance in 2019: a systematic analysis - Antimicrobial resistance poses a major threat to human health around the world. Previous publications have estimated the effect of AMR on incidence, deaths, hospital length of stay, and health-care costs for specific pathogen—drug combinations in select locations.

The study (funded in part by the Fleming Fund) from the Global Research on Antimicrobial Resistance (GRAM) Project provides the most comprehensive and robust estimates on the global burden of AMR to date. It estimates that in 2019, there were 1.27 million deaths globally attributable to AMR, higher than HIV/AIDS or Malaria. Access the GRAM project paper HERE.

January Webinar Recap

The first webinar of 2022 was an exciting opportunity to celebrate nine Nigeria Cohort I Fellows who came to the end of their fellowships.

Lead mentors Nandini Shetty and Rene Hendriksen (from Host Institutions the UK Health Security Agency and the Technical University of Denmark, respectively), shared their experience with the Fellows over the past two years.

Reflection – SHPA Virtual Foundation Seminar in Infectious Disease

Ágata do Espirito Santo Soares, Timor-Leste AMU/AMC Surveillance fellowship

The virtual seminar in infectious diseases was held in June 2021 by The Society of Hospital Pharmacists of Australia (SHPA). Attending this seminar was an opportunity to improve my understanding of Antimicrobial Stewardship (AMS) and infectious diseases.

The presenters at this seminar were highly experienced and the materials supplied were very practical from a clinical perspective. The real-life patient cases presented were fantastic, and I felt that it was a great opportunity to improve my understanding of the AMS and infectious disease fields. The seminar was particularly applicable to my role as a senior pharmacist and an AMU/AMC Fellow.

A highlight of this experience, for me, was to "meet" my AMS pharmacist colleagues from Australia. This seminar provided us with self-paced learning material which I can share with my colleagues and other pharmacists in Timor -Leste to improve their practice.

I experienced a slight challenge participating during the breakout session discussion due to a minor language barrier. Despite this, I felt that the seminar was beneficial overall and will be useful for applying AMS and infectious disease concepts and learnings into my daily practice in the future.

I am so grateful to SHPA and to my mentors at the Doherty Institute for giving me this wonderful opportunity to join the seminar.



Satisfaction SurveyResults

The most recent round of the Fellowship Scheme satisfaction survey, from October - December 2021, saw a high level of reported satisfaction from Fellows who are making progress on workplan activities, and from Beneficiary Institutions and Host Institutions within the scheme.

Reported satisfaction was also higher across all respondents compared to the previous survey from January - March 2021 (see graph below for comparison).



Fellow Responses

The recent survey results showed similar trends to previous surveys. At least 90% of Fellows who took part in the survey responded that they were satisfied (or higher) with their Host Institution, the responsiveness of their host institution, and the quality of mentorship.

In addition, 95% of responses indicated that professional development activities provided by their Host Institution has been relevant to both their role and future career options.

According to Fellows, international and in-country travel restrictions have been the main COVID-19-related impacts on their fellowship activities since March 2021.

Beneficiary Institution Responses

The most recent survey results also displayed similar trends to previous surveys, with at least 90% of responses from Beneficiary Institutions showing a level of satisfaction (or higher) with the benefits of the Fleming Fund Fellowship Scheme.

Responses from Beneficiary Institution reflected that participating in the scheme has improved the capacity of their institution and they would be happy if other staff applied to the scheme in the future.

For the respondents from these Institutions, the most prevalent key benefits of participating in the Fellowship Scheme are technical capacity, leadership capacity and strategy development.

Host Institution Responses

Like Fellow and Beneficiary Institution survey results, the most recent survey results from Host Instructions showed similar trends to those from previous surveys.

At least 90% of Host Institutions respondents indicated that they were satisfied (or higher) with the benefits of the Fleming Fund Fellowship Scheme, the compatibility of selected Fellows to their thematic area for development, and the engagement of selected Fellows with their workplan.

Additionally, at least 95% of Host Institutions that responded to the survey would be happy to take part in another Fleming Fund Fellowship Scheme or work with Fellows after the Fleming Fund has ended.

Next Steps

Currently, the Fellowship Team is reviewing the satisfaction survey results with attention to the challenges and risks highlighted in responses. We will provide more information on our next steps and actions to address these challenges in future Petri Dish issues.

The satisfaction survey is an important platform for Fellows, Host Institutions and Beneficiary institutions to feedback on the Fellowship Scheme. The next survey will be sent out between July-September 2022.

Nuryani Zainuddin – AMR Policy, Animal Health (Indonesia)

I am the Director of Animal Health in the General Livestock and Animal Services Directorate within the Indonesian Ministry of Agriculture. My directorate is responsible for policy formation and implementation, as well as providing technical guidance and evaluation in the field of animal health.

As a government veterinarian, I am concerned with animal protection, disease investigation and

prevention, and veterinary drug control. I have experience collaborating with human, aquaculture and environmental sectors, and have worked on a joint initiative to develop the AMR National Action Plan. I also worked on increasing AMR and AMU surveillance capacity and raising AMR awareness with national stakeholders, including academic institutions, private sector corporations and farmers.

Through this Fellowship, I want to increase my capacity in policy strategy development for AMR and antimicrobial control in Indonesia, while collaborating with different sectors on controlling antimicrobial use.



Nelly Puspandari – AMR Policy, Human Health (Indonesia)

I am a medical doctor and also a clinical microbiologist. I am currently a Senior Policy Analyst in the National Institute of Health Policy and Development within the Ministry of Health.

In addition to my role in the Ministry of Health, I have been involved in the Indonesia AMRCC and the development of the AMR National Action Plan.

I was the focal point for National Coordinating Centre for AMR Surveillance. Through my career, I have

worked on several AMR studies and surveillance projects in Indonesia.
