# Nigeria, Building the Ship against AMR as they Sail It by Emmanuel Benyeogor

Four Nigerian fellows made a trip to Denmark earlier this month for a four-week training course provided by our Host Institution, Technical University of Denmark. For many of us the, biggest surprise was coping with the cold, with temperatures averaging 5°C accompanied by a strong wind off the sea.

During the third week of training, we recorded and produced short videos to commemorate World Antimicrobial Awareness Week tagged with the slogan "The Future of AMR Depends on Us All".

Back at home, in Nigeria, the Government and several partner organisations held a host of activities highlighting the dangers of antibiotic resistance. Activities included an awareness walk, media training, social media posts and tweet chats using #AfricaWAAW and #NAAW, school, abattoir and meet market visits and the AMR Guardian Pledge website launch. The Guardian Pledge encourages farmers, citizens, doctors and educators to make a pledge to use antibiotics wisely.

Although the Antimicrobial Awareness Week has passed, we keep pushing despite the odds to prevent and control antimicrobial resistance. We are building the ship while sailing it. The future of antibiotics depends on us all. Let us become engaged today so we can see real change happen.

# Why do we focus on surveillance?

We believe data provides the power to tackle AMR. Data from national laboratories helps build a global picture of how AMR is spreading and where it poses the greatest risk. Analysis of data from laboratories also helps provide better treatment for sick patients and inform national health policies.

### What is One Health?

According to the Tripartite (WHO, FAO, OIE), a "One Health" approach to pubic health is a response where multiple sectors (human health, animal health and environmental health) communicate and collaborate to achieve better public health outcomes. Because resistant bacteria can be freely transferred between humans, animals and the environment, a holistic response is needed to combat AMR.
